
The Gosford Field Day will be on in February so we will look at a car pool system or would you like me to book the bus we used last year?

# WIA MEMBERSHIP FALLING.

The Editor's Comment appearing in the November 1998 issue of the journal of the WIA, Amateur Radio, indicates a serious fall in membership of our national institution.

Further, the comment raised the question as to whether or not the institution can afford to continue to produce the monthly journal. Surely a great shame if it comes to pass that Amateur Radio magazine disappears, after over 60 years of being alive and well.

A fall of 50% in membership, over a period of just 10 years, cannot go unnoticed, and certainly could be perceived as making a clear statement that there must be an underlying, and unidentified, problem within the culture of our hobby, and/or within the Institute itself.

It has already been expressed in published correspondence to the A.R. Editor by Max (VK3GGM), and it must be painfully obvious to most of us, that having only 25% of the total fraternity of approximately 16,000 doing the supporting, needs some serious thought. Serious thought that might, hopefully, bring about a review of attitudes amongst those of us who have "dropped out" (for whatever reason) should not be too much to anticipate.

Max included a suggestion in his letter to A.R., whereby our annual licence fee include automatic membership of the Institute. He has put substance behind his pen with the following:

"If the WIA could negotiate a deal with the ACA whereby WIA would be responsible for the collection of Licence Fees and the issue of call signs, etc., the matter of membership would be resolved." Whilst acknowledging that the above proposal may not appeal to ALL (and it certainly does NOT appeal to me), Max has at least given a pointer to a possible positive approach. There must surely be other approaches that may involve nothing more than an individual rethink about the desirability of collective support for a national body that represents our hobby, interests, and rights both nationally and internationally. Such a body, without sufficient financial resources to produce a regular journal to keep membership abreast of "the politics" at home and abroad, must surely be a body of questionable worth. If the magazine "gets dumped", how effective will WIA be without it, and what is the prognosis for WIA's survival thereafter?

How do members of the O.R.A.R.C. feel about the situation, and Max's suggestion? Or perhaps some other suggestions for action?
